







Idaho Data Summary

- Idaho has had I/3 of the new cases of COVID 19 compared to Oregon and I6% of the new cases in Washington in the last two weeks
- Lowest estimate of people fully vaccinated 26% estimate versus 28.8% of Oregonians, and 30.6% of Washingtonians












Oregon Data Summary


- Overall emergency department visits continued to increase. ED visits for Al/AN increased from the previous two weeks.
- For Al/AN, ED visits for coronavirus diagnosis increased compared to the past week, and have seen an overall upward trend over the past 6 weeks.
 - Rates for non-Al/AN have also been increasing over the past 6 weeks.

- Al/AN rates for COVID-19 diagnosis decreased from the previous week, though CLI visits for Al/AN rose slightly.
 - Non-Al/AN rates for COVID-19 diagnosis and illness visits continue to see an upward trend.
- There were 0 ED visits for COVID-19 vaccine adverse events for AI/AN again this week.
 - Al/AN ED visit rates for suicidal ideation and psychological distress decreased from the previous week.











Washington Data Summary

- Total health care visits (for Al/AN and Washington State as a whole) are about the same as the previous week.
- Al/AN COVID-19 diagnosis and COVID-like illness health care increased again for the seventh week, from 79.5 per 10,000 health care visits in the previous week to a rate of 91.4 per 10,000 health care visits.
 - Rates for non-Al/AN have also continued to increase from the previous seven weeks.
- There was a slight increase for AI/AN pneumonia health care visits from the previous week.

- The AI/AN rate for COVID-19 vaccine adverse events decreased after a sharp increase in the previous week; the rate is still based on a small number of cases (<10).
- For AI/AN, rates for suicide ideation and attempts increased from the previous week.
 - Rates non-Al/AN for these visits remained stable.

- S.1365 Extending Tribal Broadband Priority Act of 2021
 - **Sen. Elizabeth Warren** would require the FCC to open a new 2.5 GHz Rural Tribal Priority Window that lasts at least 180 days, to commence no later than 30 days after the bill is enacted
- · H.Res.344 / S.Res.172 Declaring Racism a Public Health Crisis
 - House (Rep. Hayes of Connecticut) / Senate (Sen. Brown of Ohio)
- H.R.2767 Peers in Medicare Act
 - Rep. Chu of California and Rep. Smith of Nebraska



Administrative and Regulatory Updates

- Indian Health Service reopened the comment period on the Acquisition Rules to Implement the Buy Indian Act
 - Consultation occurred in November 2020
 - Comment period extended to June 21, 2021
- HHS Advisory Council Meeting on Alzheimer's Research, Care and Services
 - May 3, 2021 from 10am 1:30pm Pacific
- HIPAA Privacy Act Notice of Proposed Rulemaking
 - Comment period extended to May 6, 2021, 3pm Pacific
 - NPAIHB hosting a discussion on proposed changes on April 28, 2021 from 2:30 3:30pm Pacific
