Sheila Blacketer

RDH, Dental Department Manager, Confederated tribes of Grand Ronde

Sheila Blacketer, RDH graduated from OHSU in June of 1998 and started working for the Tribe in July 1998. My career was mainly clinical with some outreach at that time. In 2010 I became the Prevention Coordinator and started developing outreach programs. The ideas and approach were informed by clinical practice, Native American Culture and Tribal history, in which I'm constantly learning. Outreach resonated with me and while developing programs, we as a department, realized it was more than providing prevention services outside of clinical practice. In 2015 I became supervisor for the Dental Assistants and in 2020 I became the Dental Clinic Manager. My goal for our department is to keep making connections for outreach and to support the staff in a way that makes everyone know their worth.



Dr. Jesse Brannan

Dental Director, Puyallup Tribal Health Authority

Dr. Brannan is a general dentist and has been the Dental Director for the Puyallup Tribal Health Authority since September of 2021. At PTHA, Dr. Brannan oversees a busy urban clinic with 19 chairs and over 34 employees. He began his education at The University of Washington, earning a BS in zoology and a BA in psychology. He then spent 6 years working on a transplant tissue procurement team before attending Case Western Reserve University School of Dental Medicine, where he graduated with high honors; earning numerous awards and election into Omicon Kappa Upsilon National Dental Honor Society. Dr. Brannan continued his training, completing a Certificate of Residency at the VA Puget Sound Health Care Center in 2014. After residency, he was asked to stay on at the Veteran's Administration hospital as a staff dentist, where he spent 6 years working in a multidisciplinary setting. He left the VA in early 2020 to join the team at Puyallup Tribal Health Authority.

A life-long learner, Dr. Brannan attends many conferences and continuing education courses throughout the year. Although not a content expert on treating dental emergencies, Dr. Brannan is well versed in current guidelines, and his experience working in a busy urban tribal clinic has allowed for extensive experience in this aspect of dentistry. He offers a real-world perspective on a subject where no two scenarios will be alike. When not focused on dentistry, Dr. Brannan enjoys camping and boating with his wife and three children.



Dr. Danica Brown

Vice President for Resilience and Healing, Kauffman & Associates, Inc.

Danica Love Brown, MSW, CACIII, PhD, is a citizen of the Choctaw Nation of Oklahoma born and raised in northern New Mexico. Danica is the Vice President for Resilience and Healing at Kauffman and Associates, Inc. and has worked as a mental health and substance use counselor, social worker, and youth advocate for over 20 years. Danica is an Indigenous Wellness Research Institute ISMART fellow alumni, Council of Social Work Education, Minority Fellowship Program fellow alumni, and Northwest Native American Research Center for Health fellow alumni. Her research has focused on Indigenous Ways of Knowing and decolonizing methodologies to address historical trauma and health disparities in Tribal communities.

Danica is faculty for the Harm Reduction ECHO, Journey to Health ECHO, NW Elders & Knowledge Keepers ECHO, Substance Use Disorder ECHO, and Trans & Gender-Affirming Care programs, which are designed to provide comprehensive information for behavioral health specialists to effectively integrate services and promote healing so that our communities thrive.

Dr. David Carsten

DDS, Oregon Health Sciences University

David Carsten, DDS, is a dentist anesthesiologist. He has a BS in Biochemistry from Washington State University with background in Medical Bacteriology and virology. At WSU he researched E coli and their bacteriophages. His DDS is from the University of Washington. He has 8 publications in the scientific literature. He received the Award of Distinction in Continuing Education from the Academy of Dentistry International.

He is an Assistant Professor in Hospital Dentistry at Oregon Health Sciences University. He is Course Director for OS725, Anesthesia and Sedation in Dentistry for DS2 students at OHSU. This course utilizes an OSCE final examination designed much like the DLOSCE. He was on the ADA Steering Committee for the DLOSCE. He was a member of the Technical Advisory Group through the Council of State Governments to set up an interstate dental and hygiene licensure compact. He mentors the interdisciplinary learning group at OHSU, the Tilikum Crossing Seminars.

Dave is the two-time Chair of the Washington State Dental Commission, also chairing the Infection Control Committee. This committee rewrote the infection control regulations for Washington state dental settings, working to meet the CDC guidelines. After 30 public meetings over four years, the regulations passed the dental commission, including regulations on waterline safety, sterilization of handpiece motors, and many other aspects of infection control. Dave is a member of the CDC committee that is revising the 2003 infection control guidelines, primarily related to waterlines. Dr Carsten spoke at the OSAP annual meeting in 2020 and 2022. Dave and his residents provided care through the Emergency Dental Care Clinic during the pandemic shutdown for the region. Dave lives in Vancouver with his wife, Sharon, his son, Davin, and their dog, Kiki. He has been a member of the Spiritual Care Team at Salmon Creek Legacy Hospital since 2012.



Sarah Chagnon

Dental Therapist, Swinomish Indian Tribal Community

Sarah Chagnon is a practicing dental therapist for her tribe, Swinomish, in LaConner, Washington. Sarah is the past president of the American Dental Therapy Association (ADTA), the student section liaison for the American Public Health Association (APHA), a lead for the Swinomish Health Promotion Disease Prevention (HPDP) team, and works as adjunct faculty/instructor for the dəxxxxayəbus - Dental Therapy Program at Skagit Valley Community College. She is attending school and getting her master's degree in health administration from the University of Phoenix. Sarah is committed to her community. Her passion is ensuring her patients feel safe and comfortable in her care. She wants everyone to like their smile. She is committed to providing oral health education and tools to her community and positively impacting their oral health. Sarah has three children, Takeo, Junami, and Theodore; her favorite activities are traveling, dancing, playing soccer and making art.



Dr. Miranda Davis

Prevention Consultant, NW Tribal Dental Support Center, NPAIHB

Dr. Miranda Davis (she/her) has worked at the Northwest Portland Area Indian Health Board (NPAIHB) since 2019 where she serves as the Prevention Consultant for the Northwest Tribal Dental Support Center (NTDSC). Dr. Davis also directs the Dental Health Aide Program at NPAIHB, which includes the Native Dental Therapy Initiative. The Dental Health Aide Program assists tribes in implementing innovative workforce models to address social determinants of health and expand access to high quality oral health care.

Dr. Davis has been working in the dental field for 25 years. She first worked as a dental office and chairside assistant, then as a dental clinical research assistant at the University of California, Los Angeles. After earning her doctorate, Dr. Davis worked with Tribal clinics in Washington and Oregon for eighteen years, in private practice for five years, and she has worked as a volunteer in nine countries. She especially loved her many years working with a Tribal school-based sealant program.

Dr. Davis earned a DDS from the University of the Pacific School of Dentistry in San Francisco, and a Masters in Public Health from the University of Washington School of Public Health. Her undergraduate thesis focused on dental fears and phobias.

While working with Tribal clinics, Dr. Davis participated in many activities offered by the NTD-SC, including the Baby Teeth Matter initiative, continuing education courses, and annual area dental meetings. She is now honored to work with the NTDSC!



Asiah Gonzalez

Licensed Dental Therapist, Swinomish Indian Tribal Community

Asiah Gonzalez is a Licensed Dental Therapist, is an enrolled Tribal member of the Swinomish Indian Tribal Community. She grew up on the Reservation where she attended and graduated from the La Conner School District and is an involved member of the community. Asiah began as an Intern Dental Assistant in May 2016 while also attending a Dental Assisting Foundations Class at Skagit Valley College, then went to Alaska to pursue Dental Therapy and graduated in June 2019.

She is part of the Swinomish Canoe family and participates in events like Canoe Journey with her family where she sings, dances and would pull canoe. A common barrier for mistrust and doubt is an unfamiliar face put into the position of care where patients feel vulnerable and struggle with historical trauma. The benefit of being a native mid-level provider who is from the community is truly understanding the culture and first handedly relating to those around and creating a comfortable, trusting environment while providing the best quality of dental care and advocating as a role model for the youth. She strives to be the best for her community and pushes every day to help everyone meet their goals and love their smiles.



Angela Johnson

Dental Health Aide Therapist, Lummi Nation

My name is Tat'sem'maat, Angela Johnson. My dad's name is Sem-la nough, given name is Vernon Johnson jr. My grandpa is Vernon Johnson (Critter) from Lummi and Quinalt. My grandma is Taitla, Cecilia Johnson, originally Genge, from Tsawwassen First Nations. My biological mom is Caucasian and her name is Shelia Jacobson. My step mom is Elizabeth King-George (Betty), originally Swanaset, from Nooksack. I come from a family of 6 kids known as the Betty bunch.

There a few reasons I chose this career. I was watching a movie called Horrible Bosses. One of the main characters' job was as a dental assistant. I thought that looks fun, so I quit my job of serving and started school that Monday to join the dental world. I was a dental assistant for about 3 years at Sea mar Community Health Center. I started feeling like I was not contributing enough to the world. I learned of the Dental Health Aide Therapist (DHAT) position and became interested. I drove down to Swinomish dental clinic to shadow their dental therapist, Daniel Kennedy. Dr. Hogan informed me I would have a better chance at getting the opportunity through my own tribe, Lummi. So I put in my notice at Seamar CHC in hopes of joining Lummi dental to become a DHAT. Dr. Dubek, the dental director, hired me right away and from there I proactively pushed to become the dental health aide therapist for my community. I have always wanted to help in some way and now this is my chance to prove I can. In Tsawwassen First Nation, there is no dental clinic on the reservation, so I would also like to start a mobile dental van for the kids and possibly involve the elders and eventually anyone who can qualify for dental services in my scope. One last thing on my career bucket list is international volunteering. I would love to travel to countries that do not have dental access and provide as many services as I can.

I have many dreams, goals and aspirations, especially with my new career position. I would love to help my community achieve healthy oral cavities as well as over all health. I want to do as much as I can for as much people as I can. This is just the beginning to an innovative dentistry approach.



Jillene Joseph

Executive Director, Native Wellness Institute

Jillene Joseph is an enrolled member of the Gros Ventre or Aaniiih people from Fort Belknap, Montana. She lives in Oregon with her life partner and children. She is the Executive Director of the Native Wellness Institute and helped to found the national non-profit organization in 2000. She has a Bachelors of Science degree in Community Health Education and has served Indian Country for 30 years providing training and technical assistance in a variety of areas. Jillene has traveled to hundreds of Native communities and interacted with and learned from thousands of people. Whether she is providing youth leadership training, assisting women heal from childhood trauma or helping to bring wellness to the workplace, Jillene shares her passion for being positive, productive and proactive. She enjoys beading, reading, pow wowing and spending time with family and friends.



Dr. Sean Kelly

Clinical Consultant, NW Tribal Dental Support Center, NPAIHB

Dr. Sean R. Kelly served as a Commissioned Corps Officer within the Indian Health Service of the United States Public Health Service from 2003 to 2017. He retired as a Captain on August 1, 2017, with 26 years of combined active-duty service with the U.S. Navy. Starting as a Staff Dentist for the Puyallup Tribal Health Authority Dental Clinic, Dr. Kelly became the Dental Director in 2008. WA. Dr. Kelly resigned from his dental director position in September 2021.

Dr. Kelly graduated from the Virginia Commonwealth University School of Dentistry with Cum Laude honors in 1990. In 1991 he completed the Advanced Education in General Dentistry program at the University Of North Carolina School of Dentistry, Chapel Hill. Healthcare Investigator, Washington State Department of Health

Kate Mills (she/her/hers) has worked as a Healthcare Investigator at the Washington State Department of Health (DOH) since 2012. 

A Grandfather took his Grandson fishing with a plan to teach him a life lesson. After completing their fishing, he asked if his Grandson wanted to see him change the course of the river.
