What is Medical Logistics?

Management of resources to include consumable medical material, durable medical equipment, and other response equipment.

Functions of Our Team

- · Receive, stage, store and distribute
- Manage PPE backstop to improve supply chain resiliency
- Identify, establish and maintain items in formulary – from procurement to distribution
- Provide logistics support and guidance for other agencies and programs
- Manage deployable assets such as Command Vehicles, modular shelters, and durable medical materiel
- Develop and adhere to equitable distribution strategies

What are MCM?



Any intervention, that is implemented to prevent, protect against, treat or diagnose diseases or effects caused by a CBRNE threat agent(s).

Functions of DOH MCM

- Provide technical assistance and guidance to MCM partners during all phases of emergency cycle
- Manage allocation, distribution and DOH dispensing operations
- Administer the CHEMPACK program
- Main point of contact with the ASPR SNS program
- State-maintained MCMs
- Medical countermeasures planning

Volunteer Mgmt.

Functions of our team:

- Volunteer management coordination ensuring effective utilization of medical volunteers.
- Working with Medical Boards and Commissions for volunteer verification.
- Recruitment, scheduling, and response to medical volunteer requests.
- Screening of medical volunteers through application to the MRC and SEMRC.
- Organization of volunteers to ensure adequate coverage for medical services.
- Assessment of volunteer performance; gathering feedback to improve the program.
- Training and orientation to volunteers for understanding of their role.

What is VM?

A program providing patient care or supporting patient care services, during disasters or extended health emergencies when health care facilities need to increase their support capability.
