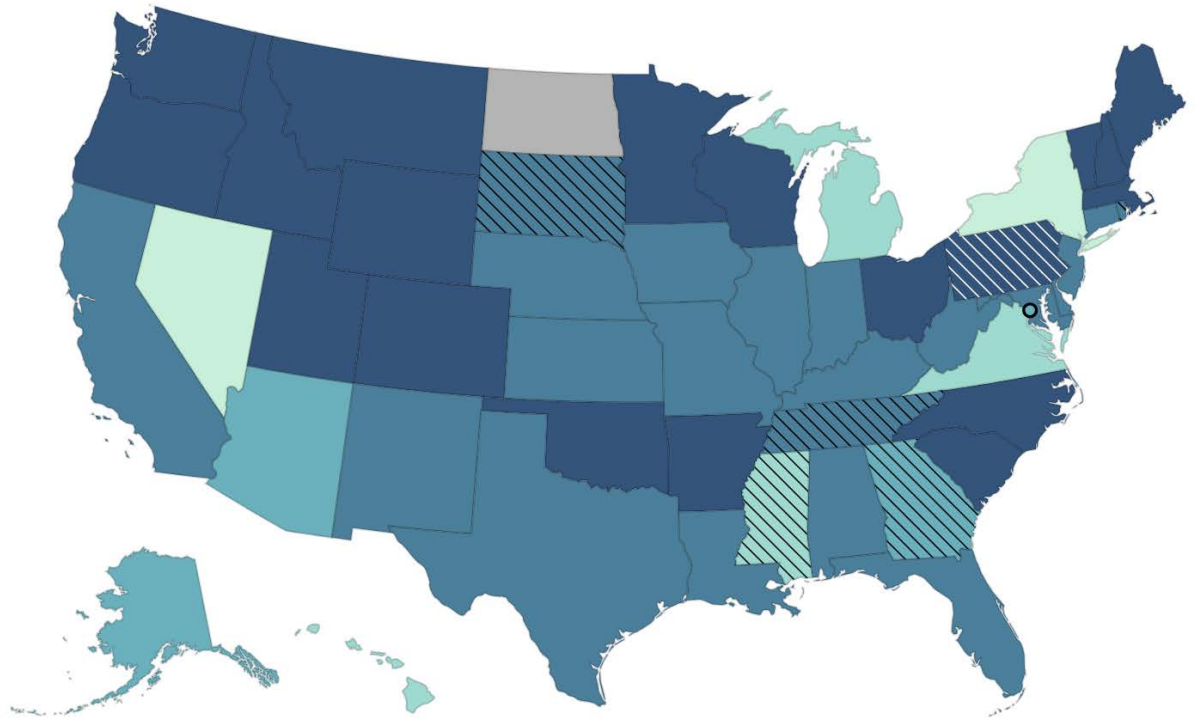

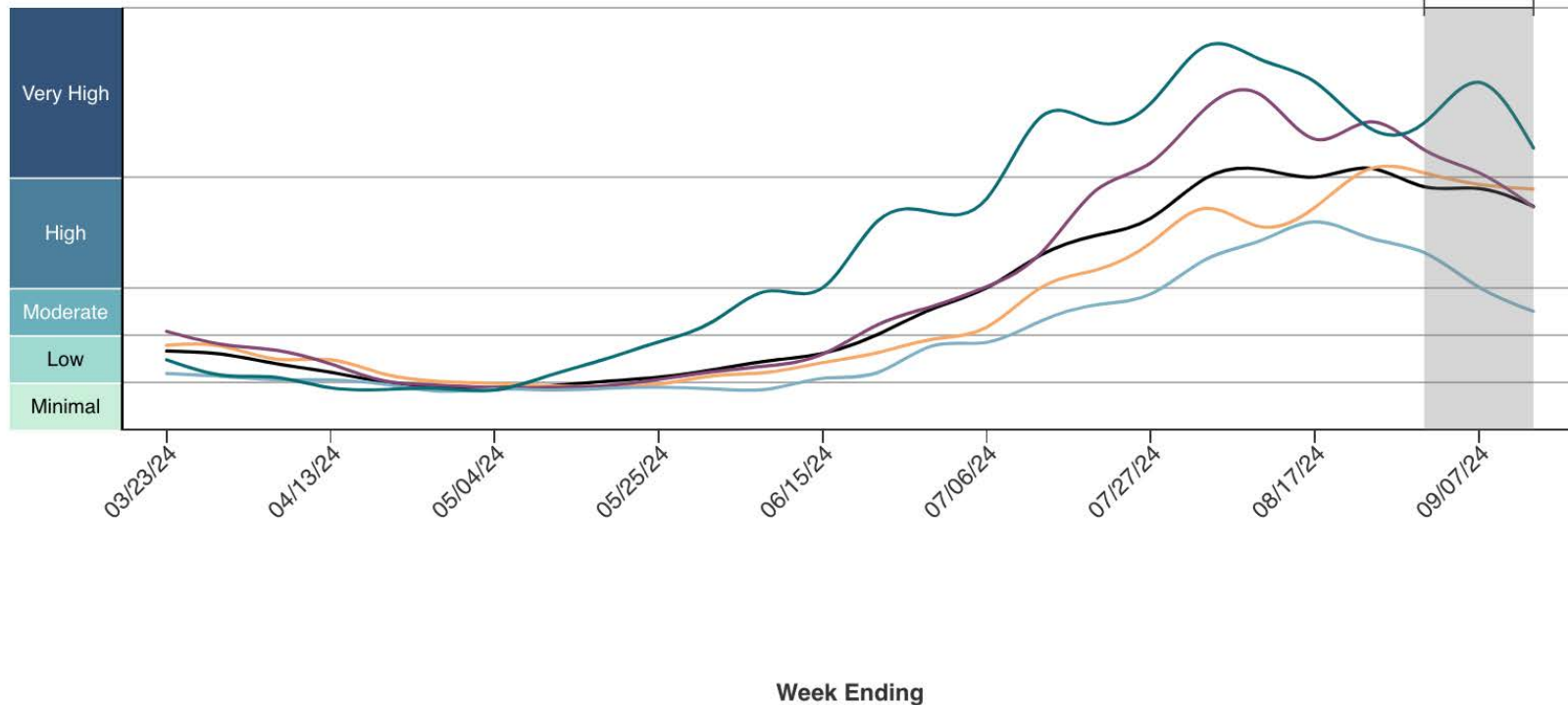

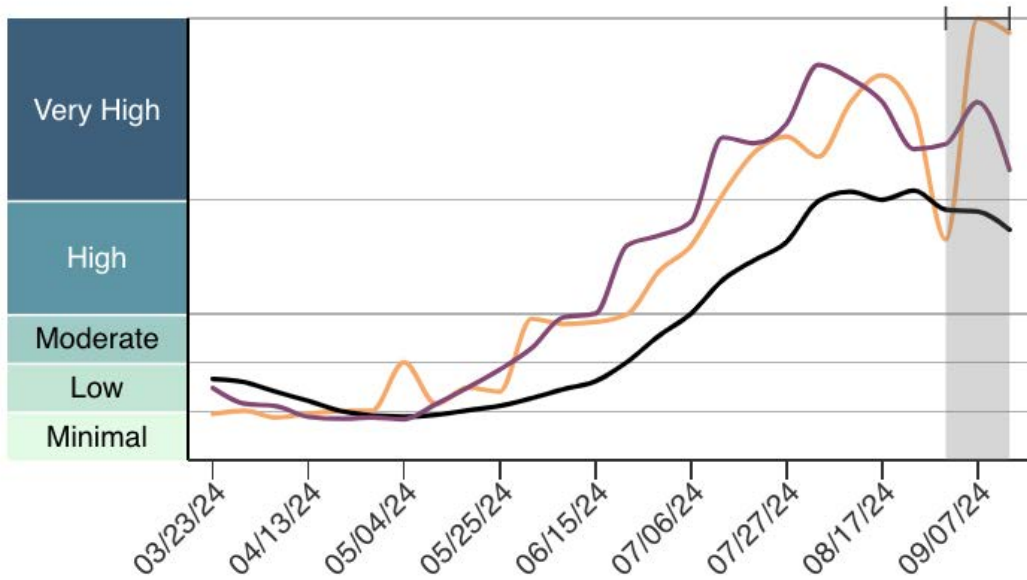

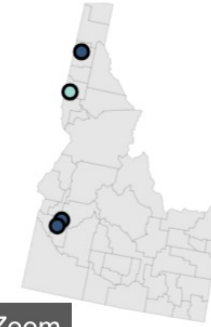

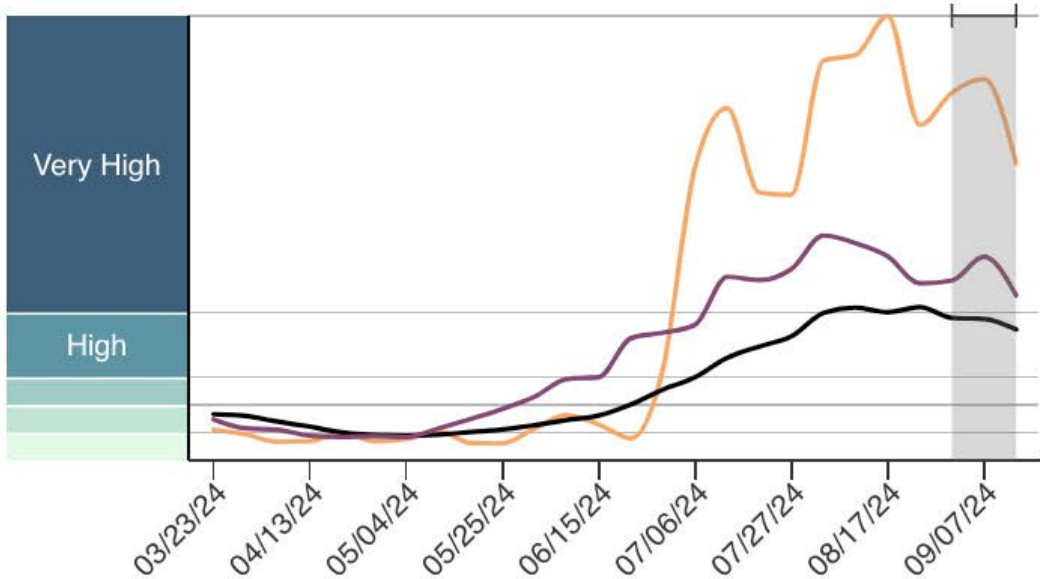

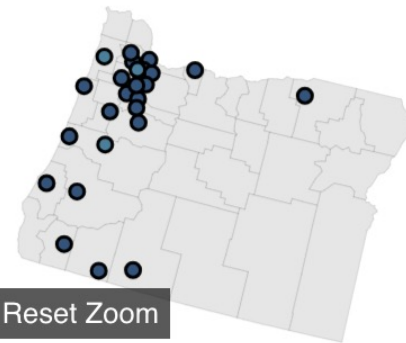

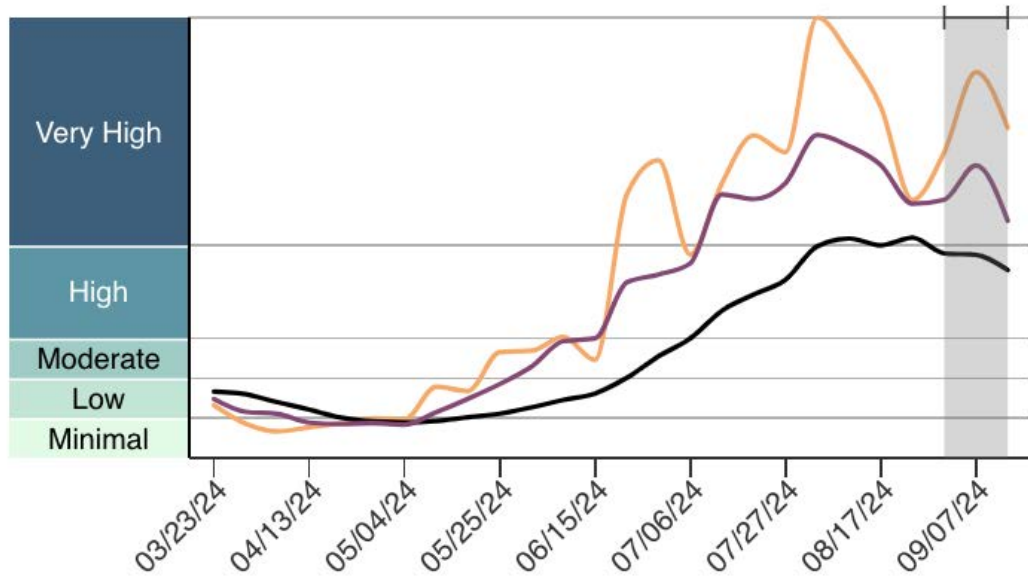

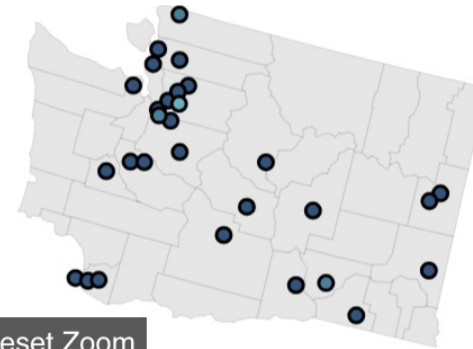

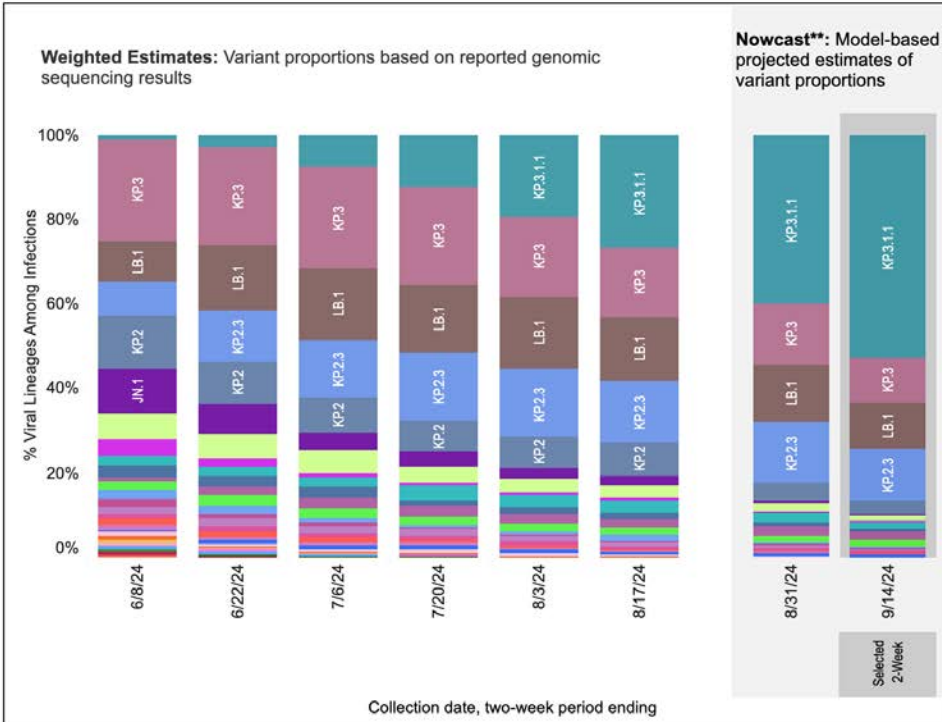

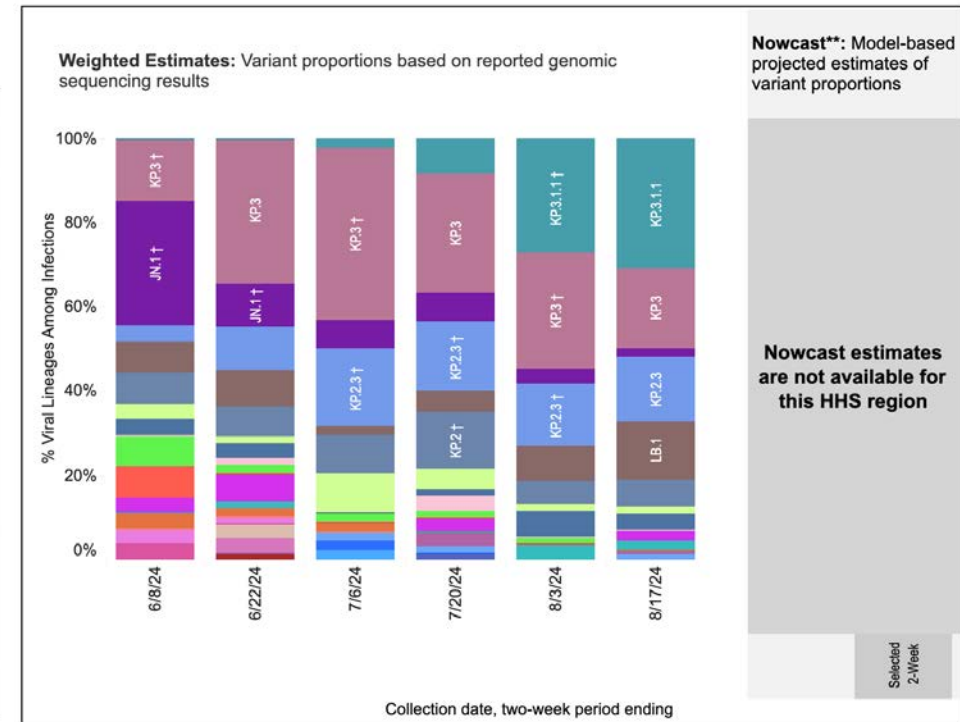

COVID-19 Emerging Variant: XEC

What we know so far:

- Omicron offshoot – combination of KP.3.3 and KS.1.1
- First identified in August, earliest cases in Western Europe May-June
- Has been detected in the US, but is not yet on the CDC COVID-19 variant tracker, which includes variants once they account for $\geq 1\%$ of cases
- May be the next dominant strain in the US & Canada by October/November
- Symptoms are similar to other variants
- Does not appear to be more dangerous or produce more severe disease than past variants; too early to say whether it's more transmissible
- Current vaccines are expected to protect against XEC (Omicron subvariants)



Tracking XEC

- 600+ XEC cases worldwide
- Most prevalent in Western Europe

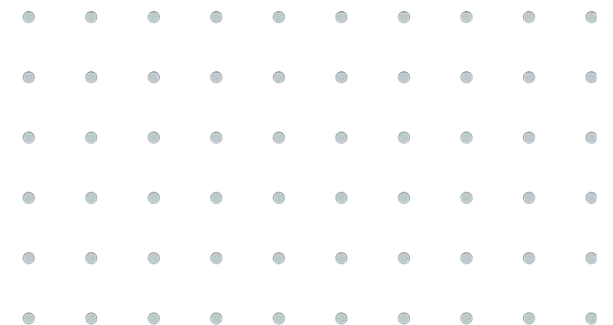
P.L. 93-638 Contract

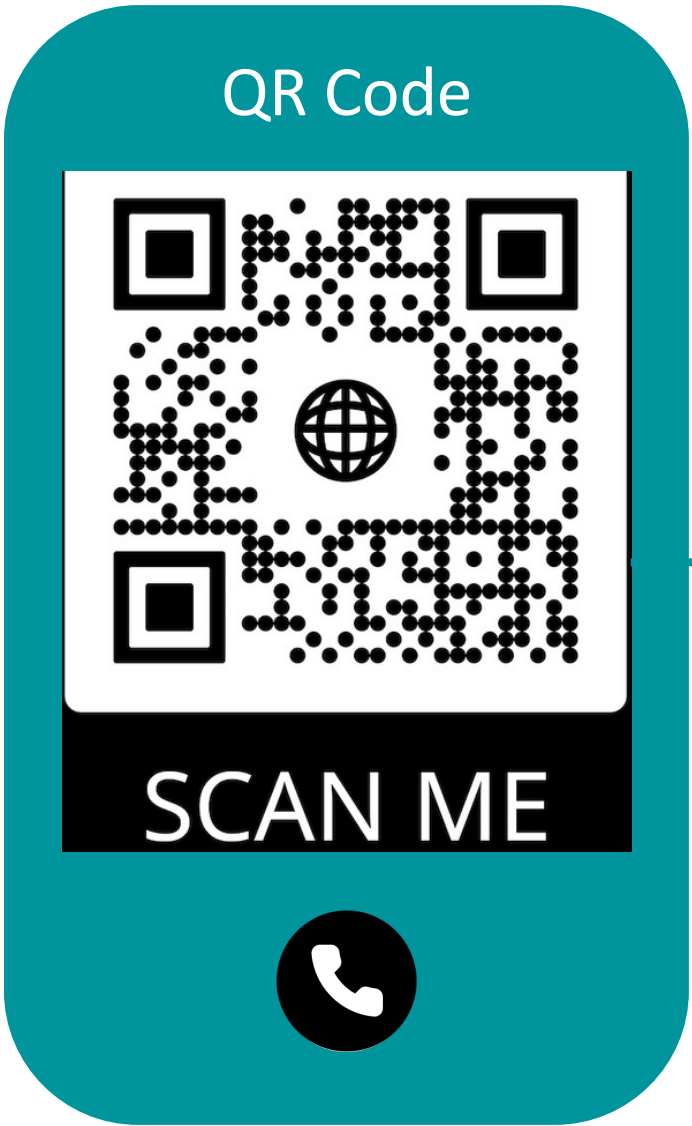
The project will be designed, constructed, and federally operated in accordance with the Program Justification Document and Program of Requirements approved and signed by IHS Headquarters.

PURPOSE

The project aims to demonstrate the benefits of regionalized specialty care and establish planning criteria for future facilities.

The facility is projected to be the first of three in the region.

House *Defeats* Continuing Appropriations Resolution

- H.R. 9494, the "Continuing Appropriations and Others Matters Act, 2025"
- Defeated in a 202 to 220 full House of Representatives vote
- Division A – Stopgap spending provisions
- Division B - "Safeguard American Voter Eligibility Act"



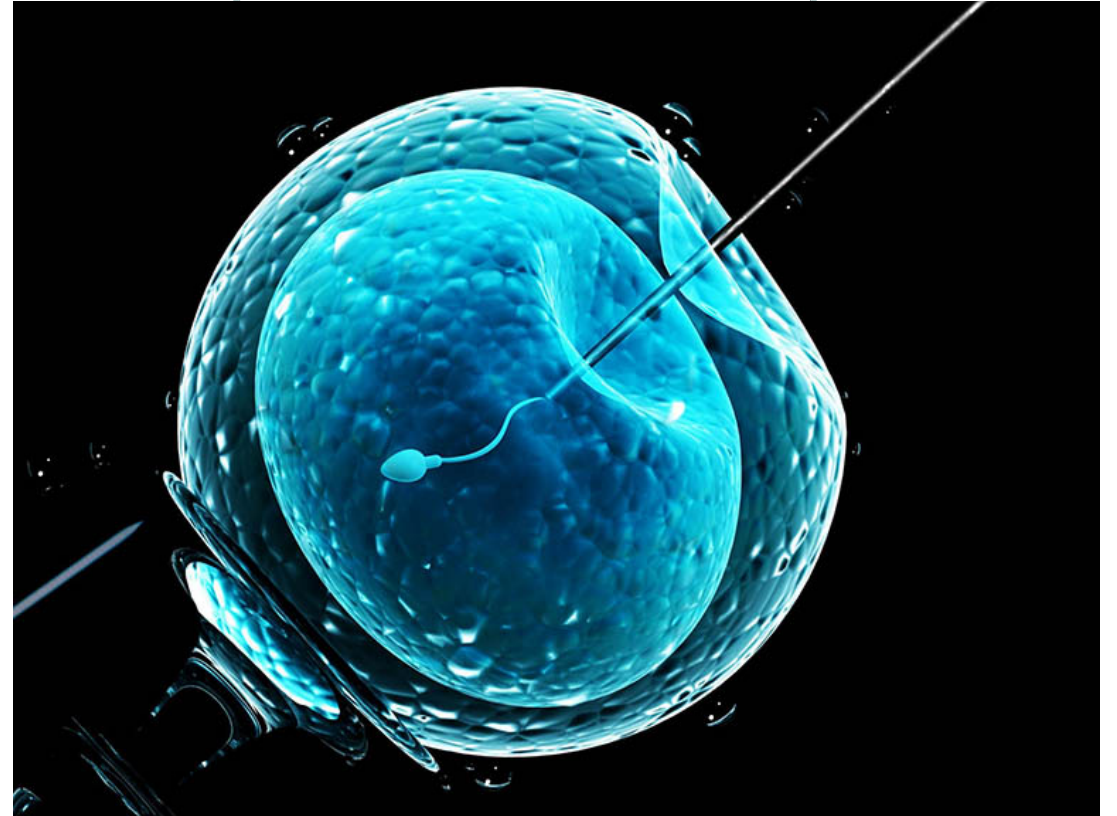
Veterans' Benefits Bill (H.R. 9468)

The House and Senate passed the supplemental appropriations bill that would fill a ~\$3 billion gap in veterans' benefits funding.



Defeated IVF Protections Measure (S. 4445)

On September 17, senators failed to achieve the required 60 affirmative votes, on the motion to proceed to consideration of legislation that would expand access to and coverage of in vitro fertilization (IVF) protections.

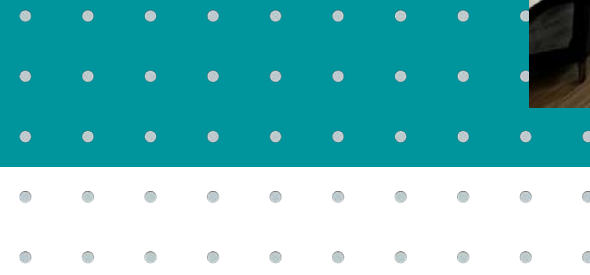

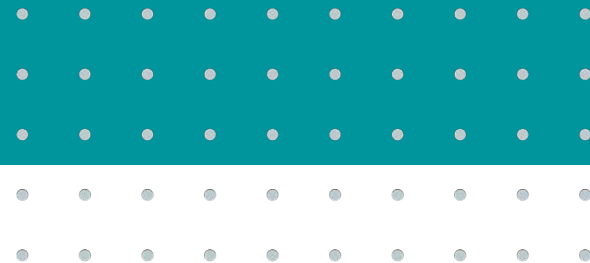

STAC Update



CHEF: Catastrophic Health Emergency Fund



Section 202(d), of the Indian Health Care Improvement Act (IHCIA)

The final rule will be effective October 29, 2024. The final rule is available on the *Federal Registrar's* website at: <https://federalregister.gov/d/2024-19421>.

The purpose of CHEF is to meet the extraordinary medical costs associated with the treatment of victims of disasters or catastrophic illnesses who are within the responsibility of the Service.

Establishing an initial cost threshold to access CHEF reimbursement at \$19,000 means more cases will now be eligible for reimbursement, which will expand access to health care in Indian Country.

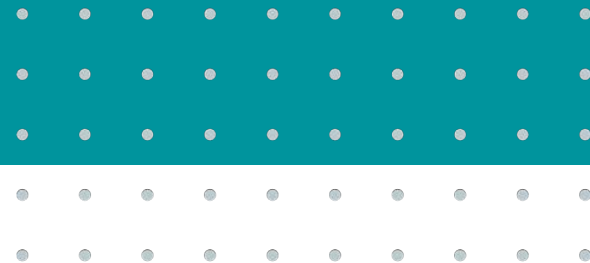
Section 202(d), of the Indian Health Care Improvement Act (IHCIA)

Washington State Tribal Prevention System: North Star Systems

- In 2022 a Youth Delegation from Lummi visited Iceland
- In 2022 Centennial Accord first agreement to partner between the State & the Tribes formalized
- 2022 Governors Office DTLL asking for interested Tribal partners
- NPAIHB collected letters of support
- Tribal Leaders from the 5 Pilot Tribes, WA Governors Office, WA HCA, AIHC and NPAIHB witnessed :
 - youth engaging in healthy activities and resources driven by community
 - Multi-organizational and governmental collaborations
- This was all the result of the implementation of the Icelandic Prevention Model

North Star System



Washington State Tribal Prevention System: North Star Systems Funding

- WA HCA has given \$70k/pilot Tribe for contracting with Planet Youth
- Washington State Governor's Office and State Legislature has given \$1 million to stand up the program for the pilot Tribes and the State Government
- NPAIHB has signed the Strategic Planning and Data Hub contract with Planet Youth
 - o CDC has funded NPAIHB as the planning and data hub for 5 years

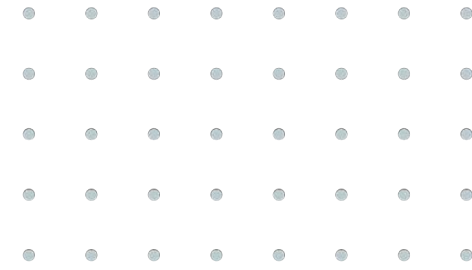
