WHAT IS THE CHR PROGRAM?

The Community Health Representative (CHR) Program is a unique concept for providing health care, health promotion, and disease prevention services. CHRs have demonstrated how they assist and connect with the community, and their work has become essential to the spectrum of Tribal community-oriented primary health care services. CHRs are great advocates, in part because they come from the communities they serve and have tribal cultural competence. Their dedicated work has assisted many to meet their healthcare needs. The health promotion and disease prevention efforts that CHRs provide have also helped people from the community improve and maintain their health. By providing health education and reducing hospital readmissions, CHRs have contributed to lowering mortality rates. The demand for CHRs continues to grow. **CHR**s are **frontline public health workers who are trusted members of the community with a close understanding of the community, language, and traditions.**

EXAMPLES OF CHR TASKS

- ▶ Provides health screenings and basic medical care
- ▶ Helps patients fill out medical forms
- ▶ Transports patients to and from appointments
- ▶ Advocates for individuals and communities
- ▶ Home checks for elders
- ▶ Coordinates care for community members
- ▶ Provides patient outreach

Background: CDC Wastewater Surveillance

- CDC's National Wastewater Surveillance System (BWSS) tracks the presence of COVID-19, Influenza A, RSV, and Mpox in wastewater (sewerage) samples collected across the US
- Infected people (and animals) can shed viral RNA (genetic material from the virus) in their feces, which can be detected in community wastewater
- Wastewater surveillance can provide an early warning of disease spread in communities, show trends, and help guide prevention strategies
- Wastewater surveillance can capture the presence of viral material shed by people with and without symptoms, to help determine if infections are increasing or decreasing
 - Doesn't depend on people having access to healthcare; seeking care when sick; or availability, use, or reporting of disease testing

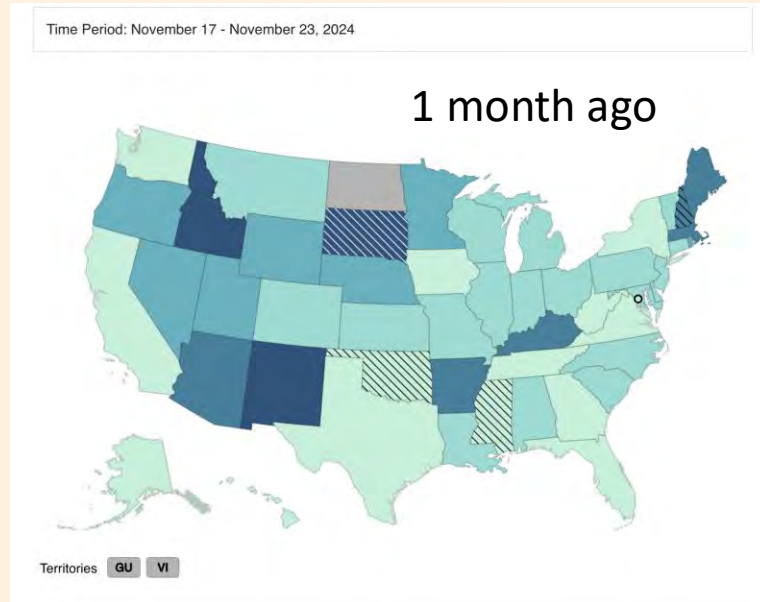


COVID-19 Surveillance

COVID-19 Current Wastewater Viral Activity Levels Map

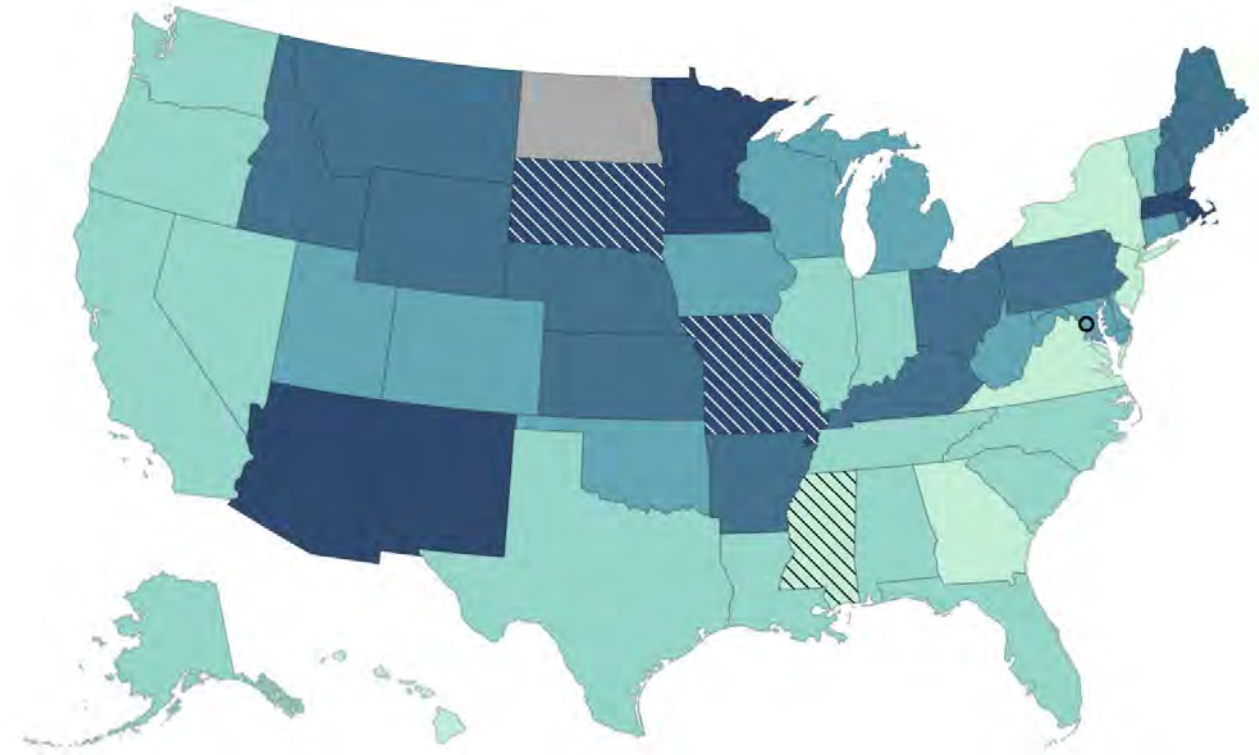

SARS-CoV-2 Wastewater Viral Activity Levels

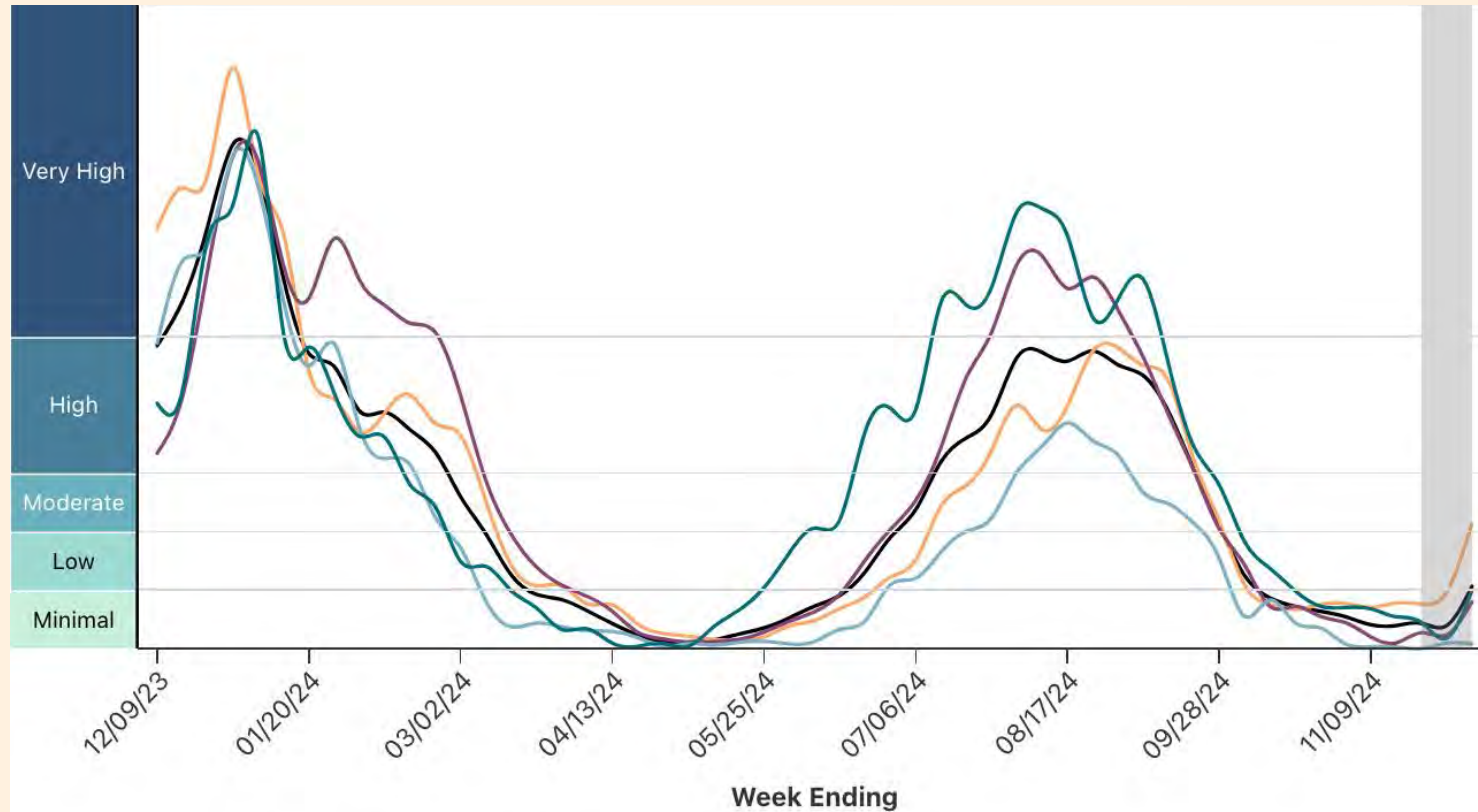

COVID-19 Wastewater Surveillance

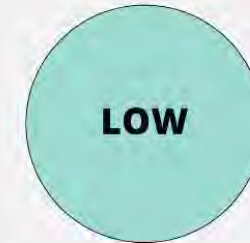

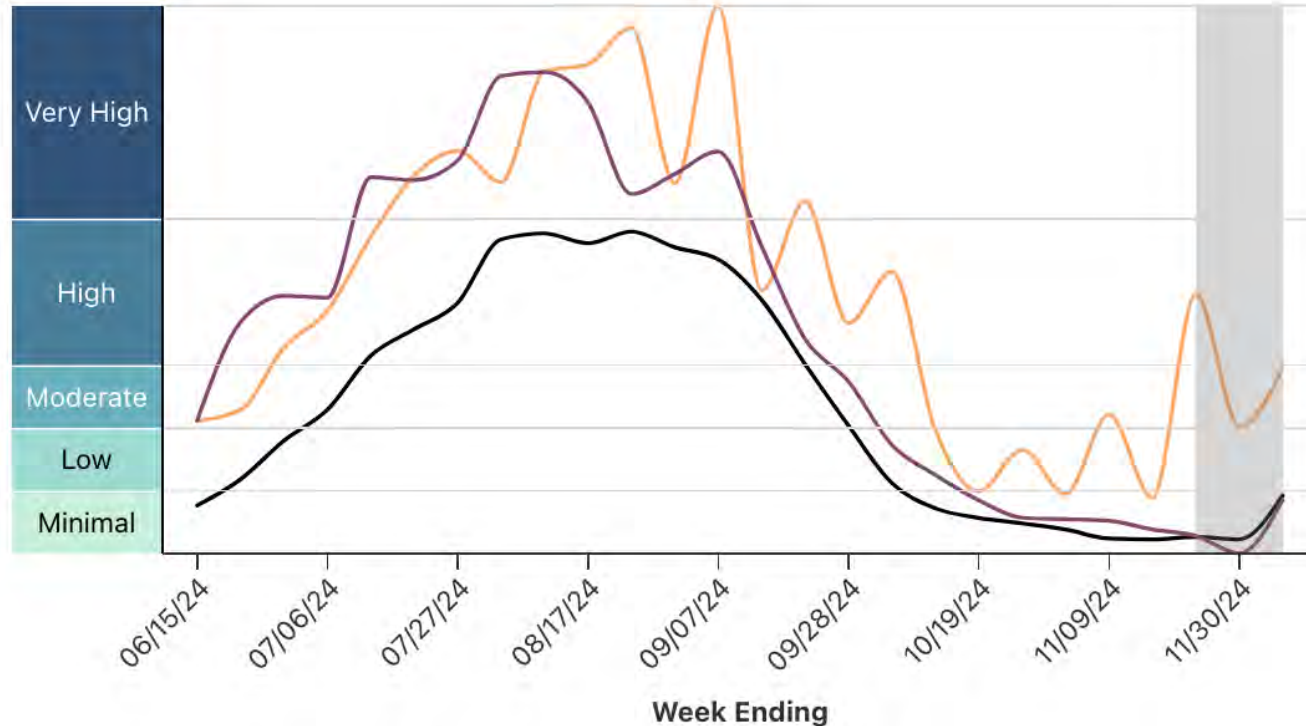

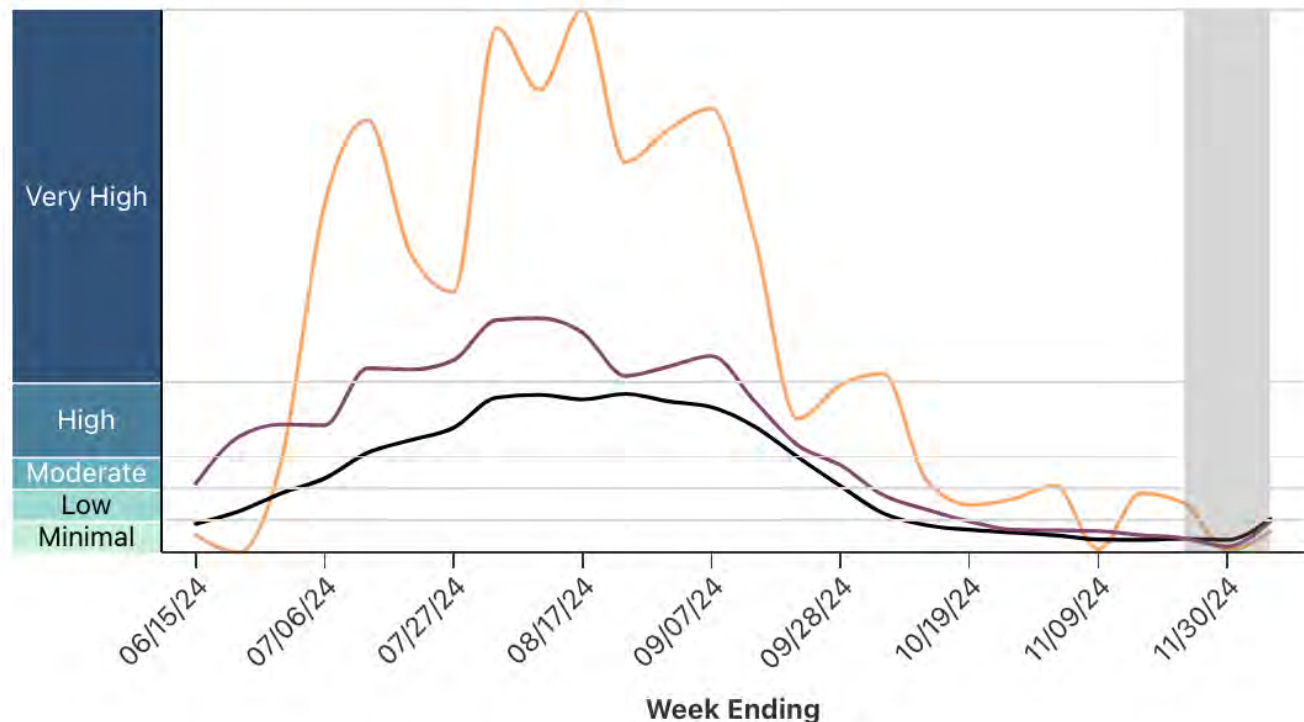

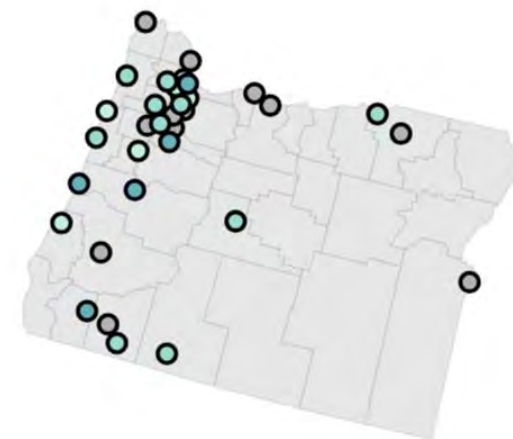
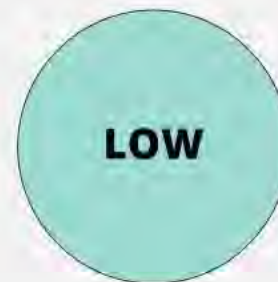


Oregon COVID-19 Wastewater Trends & Viral Activity Level

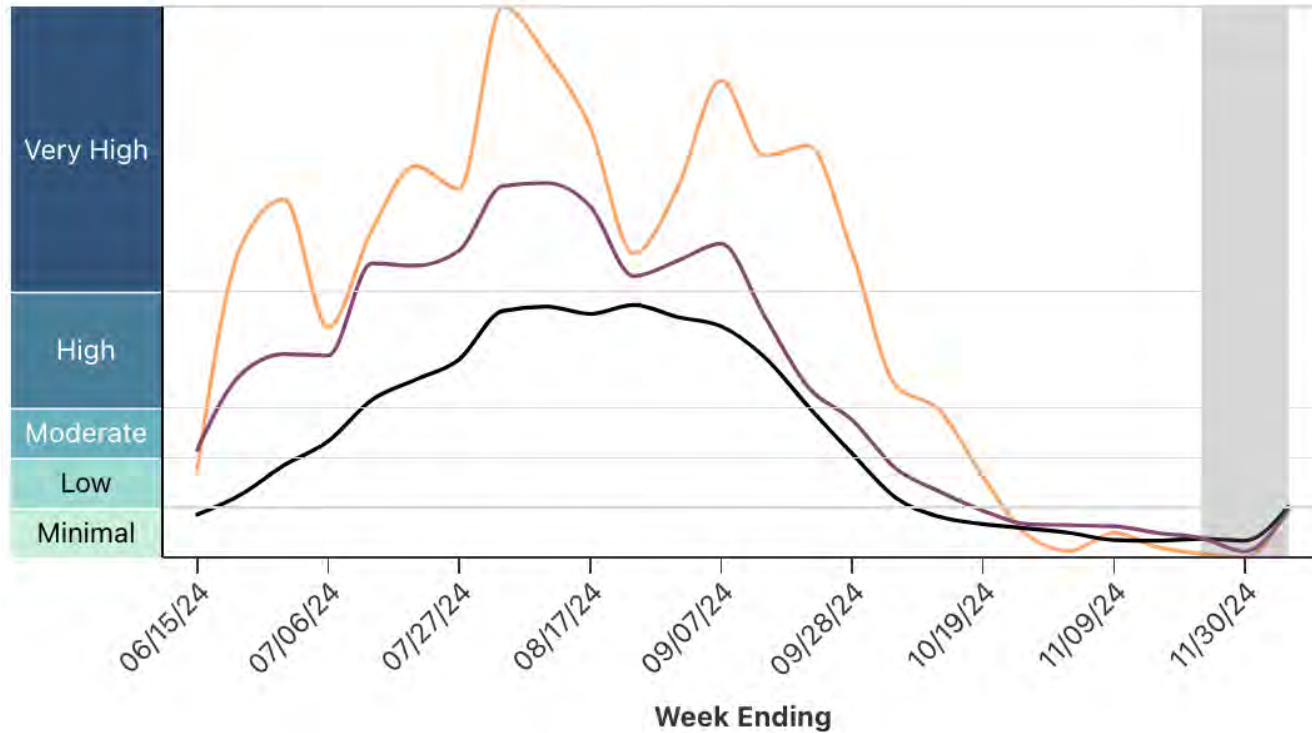

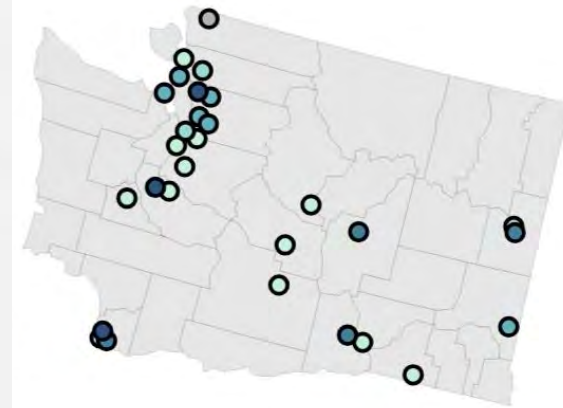


Washington COVID-19 Wastewater Trends & Viral Activity Level

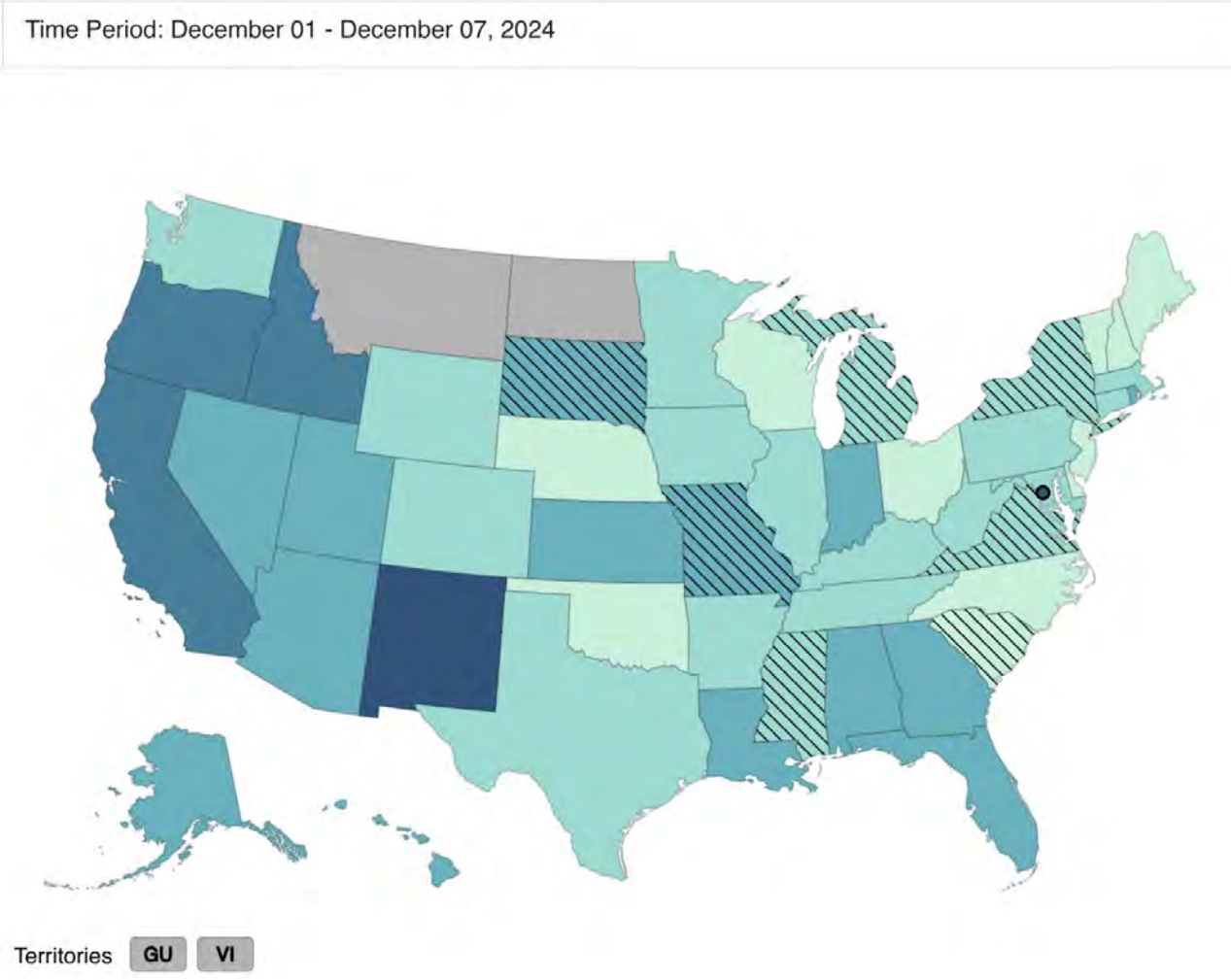
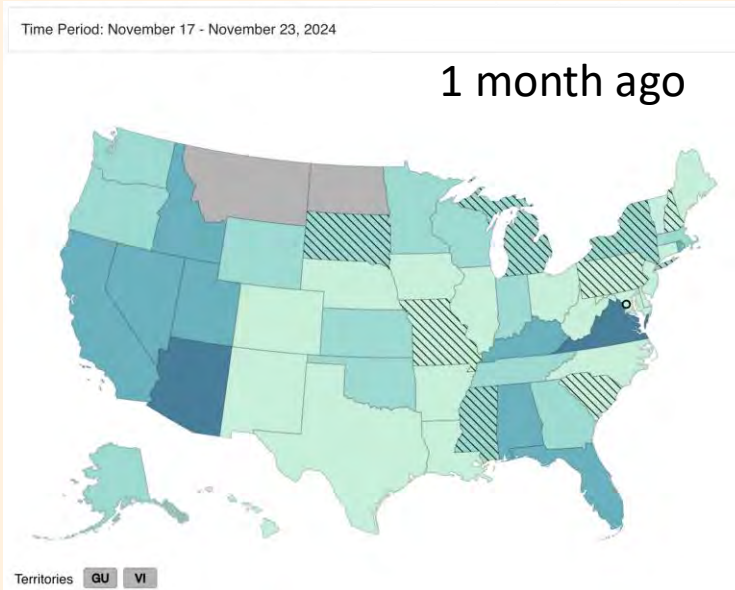

RSV (Respiratory Syncytial Virus) Surveillance

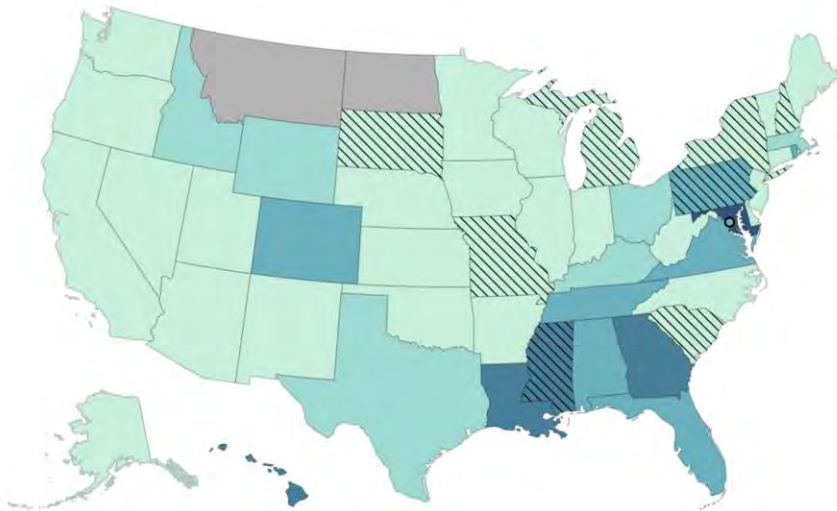

RSV Current Wastewater Viral Activity Levels Map

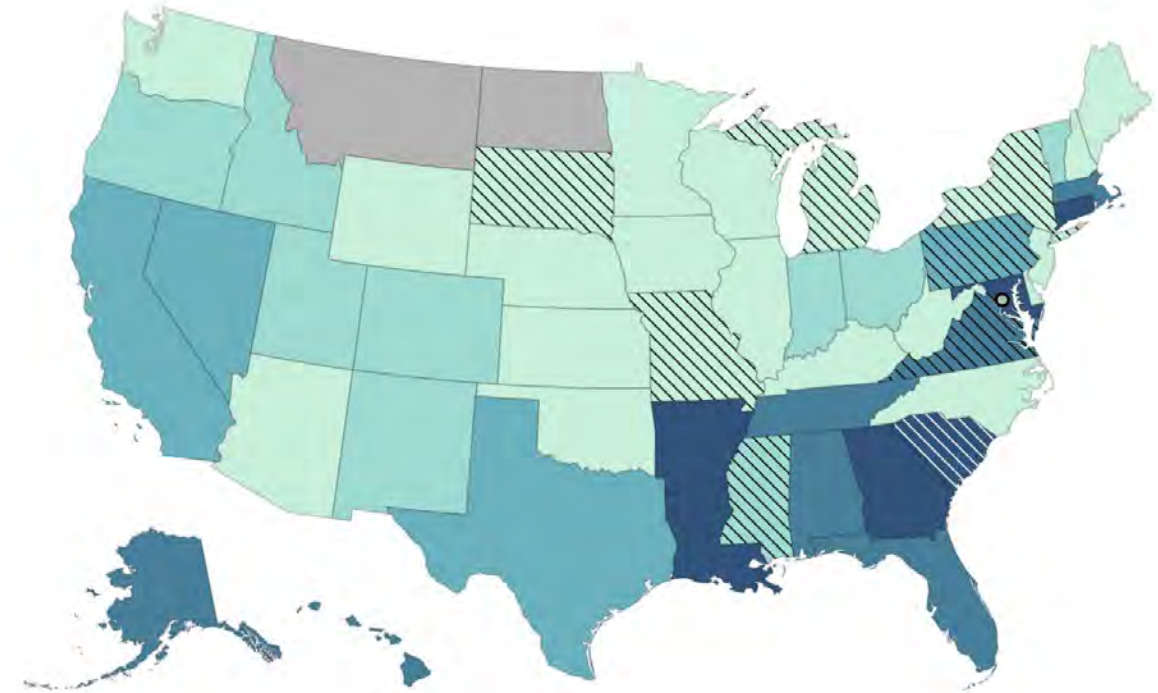

Influenza-like Illness Surveillance Report *IHS Influenza Awareness System (IIAS)*

(Week 49: 12/1/2024 – 12/7/2024)

Week Summary

- This week shows a low activity with a rate below the IHS baseline at 1.5% of outpatient visits. 4 areas report ILI activity at or higher than the national rate.
 - 7 of 10 IHS Areas reported a decrease in ILI activity from the previous week.
 - This week's IHS ILI activity is below the CDC's ILINet ILI activity for Week 49 (3.4%) and below the ILINet baseline (3.0%).
- The influenza vaccination doses administered for week 49, 2024, are about 43,744 less than those administered for week 49 in 2023.
 - To date, IHS has administered 120,764 doses of influenza vaccine.
 - Overall, 22.4% of the IHS Active Clinical population ages 6 months and older has received an influenza vaccine this season to date.
- Three areas report influenza vaccination rates at or above the national rate for all age groups: Great Plains, Nashville and Navajo
- 1.4% (1,647 doses) of administered influenza vaccines through Week 49, 2024, were recorded using inactive influenza vaccine codes for the 2024/2025 flu season. This is lower from Week 49 in 2023 (1.8%).

Opioid Treatment Program (OTP) Rulemaking

- Informative bi-monthly Information on agency rulemaking [DTLL](#)
- Main Scope:
 - Align with revised [42 CFR Part 8](#) – Federal Certification and Treatment Standards for OTPs.
 - Removed unnecessary barriers to medication access
 - Promotes the provider’s use of clinical judgement
 - Allows for take-home flexibilities that were put in place during COVID
 - Allows providers to use telehealth for admissions
 - Reduce administrative burden by removing duplicative requirements
 - Develop rules for fixed-site medication units – follows federal regulations; no fee for required notification to DOH. Units are optional.

The Washington State Department of Health Overdose Education and Naloxone Distribution Program provides free naloxone for Washington State partners, including tribes, tribal organizations, and Urban Indian Health Organizations.



Expanding naloxone access within American Indian and Alaska Native communities in Washington State

The Washington State Department of Health operates the Overdose Education and Naloxone Distribution (OEND) Program. The program offers free naloxone, overdose response training, and technical assistance to organizations interested in distributing naloxone to people at risk of opioid overdose.

The OEND program also provides free naloxone and technical assistance to tribes, tribal organizations, and Urban Indian Health Organizations, with the goal of increasing naloxone access for American Indian and Alaska Native communities in Washington State.

For the fiscal year ending June 30, 2024, the OEND program set aside \$800,000 to purchase naloxone for tribal partners. These resources will be made available annually as resources permit.

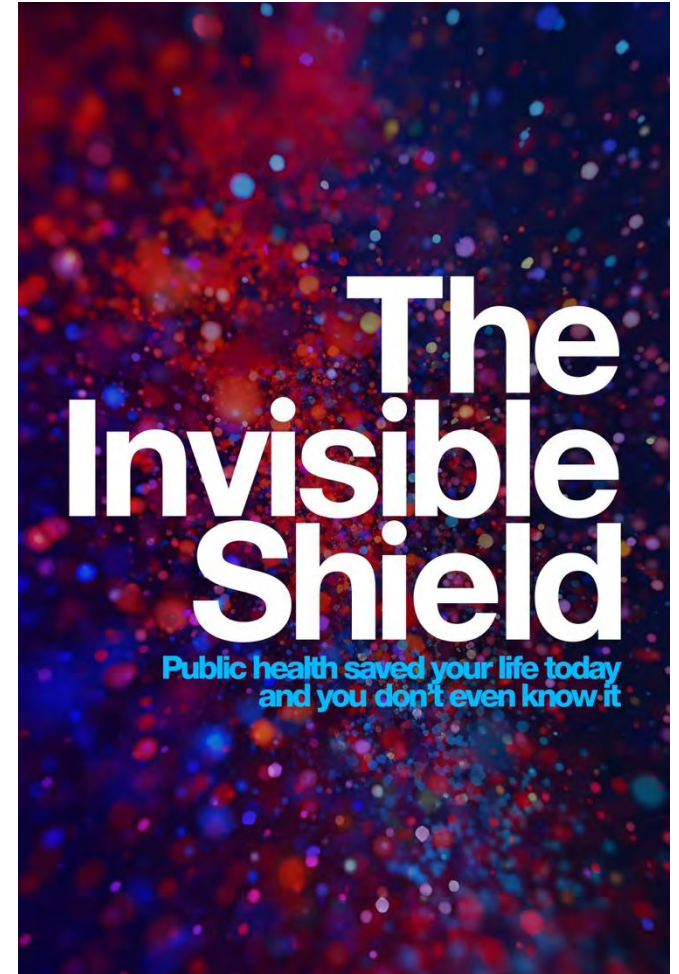

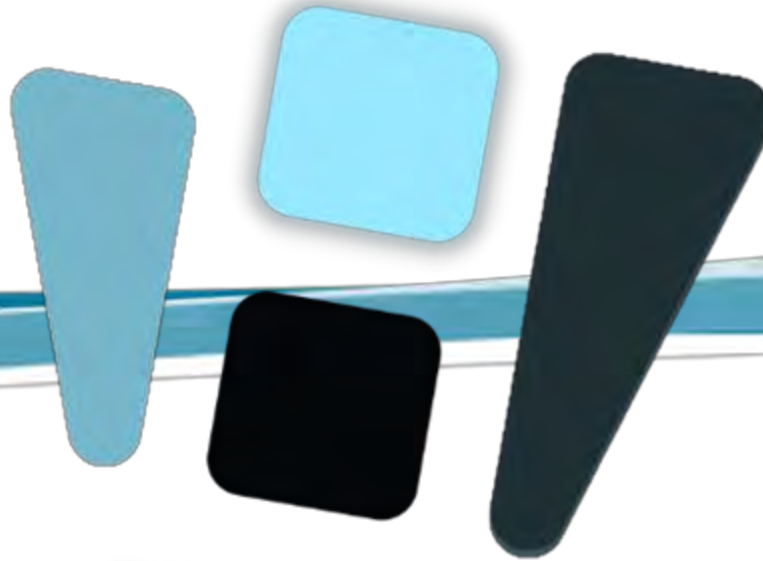
